## VOLUNTEER AGREEMENT

Casey Trees provides individuals with the opportunity to perform volunteer service with Casey Trees.

The undersigned volunteer understands that volunteer work at Casey Trees involves potentially hazardous and potentially strenuous activities.

Anyone volunteering at Casey Trees should be aware of his or her medical history and should consult with a physician prior to engaging in Casey Trees volunteer activities. The Volunteer warrants that he or she has received medical clearance to engage in the volunteer activities. Casey Trees shall have the option of requesting a written consent from the Volunteer's physician as a condition to engaging in volunteer tree planting work at Casey Trees. Similarly, the Volunteer should consult with a physician if medical or physical changes develop or appear to be developing that could affect his/her ability or safety during tree planting.

The Volunteer warrants that s/he has no condition that prevents him or her from engaging in volunteer activities offered by Casey Trees.

Anyone engaging in volunteer services at Casey Trees does so at his or her own risk. Casey Trees will not be liable for any injuries or damage as a result of such volunteer activities.

In exchange for the opportunity to perform volunteer services at Casey Trees, the Volunteer hereby agrees to release and hold harmless Casey Trees, its successors and assigns, as well as all of its past, present, and future directors, officers, agents, and employees [hereafter referred to as Releases] from any and all claims, costs, suits, actions, judgments, and expenses upon any damage, loss, or injury to Volunteer or damage to Volunteer's property arising from Volunteer's engagement in volunteer services at Casey Trees.

Volunteer further acknowledges that s/he is fully aware of any and all risks posed by his or her volunteer activities at Casey Trees, and hereby states that s/he is voluntarily assuming any and all such risks, except for gross negligence or intentional infliction of harm by Releasees. Volunteer acknowledges that he/she understands that performing volunteer services does not create a promise or expectation of possible employment or entitlement to special consideration or rights.
